'Wetland nature-based solutions' help boost resilience in the face of increasing social and environmental fragility; are necessary for society to adapt to the climate emergency and are the basis for green recovery.

Through safeguarding and restoring these wetland landscapes at scale, we can fix these problems and make a big contribution to the Global Goals, 2030.

By investing in our staff and facilitating collaboration across our network, we will increase our organisational effectiveness.
